### **SUPPLEMENTARY REGULATIONS**

**Sunday 30 August 2015**

**PERMIT NUMBER: ACU** to be advised

**ANNOUNCEMENT:** The Sheffield & Hallamshire Motor Club Limited will promote an **Open** observation and reliability trial for charity (the Event) on Sunday 30 August 2014 for solo trials motorcycles with classes for Expert, Intermediate, Novice, Over 40, Over 50, Youth Class A and Youth Class B. **No Youth Class C, D or E will be permitted to enter.**

**JURISDICTION:** The Event will be run under the ACU National Sporting Code, the Standing Trials Regulations of the ACU, these Supplementary Regulations and any final instructions published at the start of the Event.

**ELIGIBILITY:** Open to any adult rider or Youth Class A rider or Youth Class B rider with an ACU or SACU licence. Non-ACU or non-SACU riders will not be permitted to enter. **LICENCES WILL BE CHECKED AT SIGNING ON.**

**MACHINES:** Category 1, Group A1 solo machines as per TSR 8. Only solo trials machines will be permitted. **No trail, enduro or moto-cross machines will be permitted to enter. Machines will be examined before signing on.**

**START & VENUE:** The Event will start at 11:00am. The venue is Elmore Hill Farm, Brough, Hope Valley, Derbyshire and will be sign posted from the B6001 at The Plough Inn on the Hathersage to Grindleford Road. Vehicular access to the start field will be via Duper Lane, Abney and comprises a single track tarmac road leading onto a dirt track (Brough Lane). **PLEASE TAKE CARE AS THE ROAD IS NARROW AND IS USED BY RAMBLERS, TRAIL RIDERS, HORSE RIDERS AND MTB RIDERS.**

**ENTRIES:** The Event aims to raise money for Charity; accordingly the Entry Fee will be **£20:00 per rider** (Cheques made payable to Sheffield & Hallamshire Motor Club Limited). Entries **should be made by post** to the secretary of the meeting (see above details). **THE MAXIMUM NUMBER OF RIDERS IS LIMITED TO 50** and will be accepted on a first come first served basis.

**AWARDS:** There will be no cash or trophy awards or awards in kind. All money raised from the event (less event expenses payable to the ACU for levies, insurance etc and specific event running costs such as stationary and postage) shall be donated to charity. **COURSE:** All sections are on private land with kind permission of Malcolm Ollerenshaw and his family. The course will consist of 15 sections to be ridden in order over a maximum of four laps. Riders may select to ride 2, 3 or 4 laps and declare how many on the entry form. Riders will **not** be allowed to “double up” on any sections and anyone caught doing so **will be excluded from the results**. Awards will be determined on lowest observation score for the number of laps completed.

**ALL SECTIONS WILL CLOSE AT 4:00PM.** Anyone who has failed to complete their final lap of the course by this time will be given 5 marks for each section which has not been completed.

The course uses land on a working livestock farm. Please respect the land and the livestock. **KEEP TO THE FLAGGED ROUTE.** Any rider found to be deviating substantially from the flagged route **WILL BE EXCLUDED.**

**METHOD OF MARKING:** Observation will be **TSR22B NO-STOP.**
